42/25 To Approve the previous meeting Minutes

44/25 To discuss Lengthsman Activities
Cllr Rose gave an update of the latest activities. Thanks were given to the Lengthsman for his swift efforts to clear vegetation from the pavement near the boat club.

➤ Adjournment – (10 Minute max) Public Forum

Members of the public raised several County Council Highways issues; everyone was disappointed that the new County Councillor hasn't been to any PC meetings since the election and hasn't been as proactive as his predecessor in communicating on outstanding Highways matter, the County Cllr wasn't here tonight to take up these issues.

The issues raised were:

- White lines need replacing at the junction of Wheatley Road, Clayworth Common and Town Street
- A request to change the Give Way sign for a 'Stop' sign at the same junction
- Whitegates at the entrances to the village to give a psychological barrier to entering the village to hopefully reduce the speed of motorists.
- Potential to reduce the National Speed Limit on Wheatly Road
- Request NCC install the triangular 'Children Playing' warning signs for motorists in the vicinity of the village hall as the village play park is behind the village hall.
- What will happen to the outstanding Petition former County Cllr Taylor handed in to NCC regards the subsidence issue on Clayworth Common?

The Chairman explained the processes to follow and asked members of the public to report the white-lines issues on the MyNotts App with photos. The Parish Council will chase up the new County Cllr and the Highways Manager regards the outstanding petition. The Members of the public agreed to formulate a petition for the other areas of concern raised to be handed to County Cllr Robertson and to request a site meeting with him to discuss. Another member of the public explained the current situation with communication with Savills regarding the Wiseton Estate land and they are trying to ascertain who is now the point of contact, so that the annual walk and checks with regards to flooding can take place.
